Remember also that I am a person who was with the University of Phoenix and finished a doctoral program that the university failed to complete. I had my approximately \$250 thousand student loans discharged. I had a completed dissertation that was very good and was not rewarded right in 2012. I worked further on my dissertation and completed it again in another form and on a post-doctoral level. This post-doctoral level was beyond the University of Phoenix and was fully communicated about to the White House in the active times back before the summer of 2019. The White House did not do an adequacy of the relevant work that could have and should have been done when this situation was active in the times, the student loans law case in California was in its preliminary times, I had active director level materials and communication with the United States government (the White House) through more than two years, and I myself was already on a doctoral level for handling and setting anything involved with a doctoral level program. Back in the early 1990s, I had previous law work experience, including concerning Harvard Law School, U.S. Courts, and the United States, that I wanted advanced but was not while I worked in business through the following years, so after 2019, I worked further on my dissertation and made my dissertation into a law dissertation and bridged the 30 years of work I did, including law work, so in the end of 2024 I completed my law dissertation.

With everything considered of the past history and Harvard University and Harvard Law School's involvement with myself and the United States and what has been going on recently with the United States and the active regime and laws involved, is Harvard Law School not interested in seeing or working with my completed but not yet rewarded or honored dissertation that is an excellent and highly honorable dissertation? Remember, too, I am already on a doctoral level and am undealt with but am supposed to be known and dealt with on a doctoral level. I am supposed to be treated as being a doctor in my field, which was business but that I do have expanded in the years of my times to include law. Thus, I am not just an ordinary person applying to Harvard Law School and am supposed to already be considered as being a doctor professionally. The University of

Phoenix did not complete its work and left this area undealt with, and people of Harvard Law School should have an adequacy of awareness of this situation. I should not be ignored at Harvard Law School and should be understood as already being a doctor professionally and requiring to be and supposed to be further advanced and developed on doctoral levels, such as with law when I have an excellent law dissertation done in the end of 2024. This law dissertation is excellent and highly honorable but in these unique circumstances is still not rewarded or honored yet. This dissertation and all involved is a lot left out and excessively requiring through all these active times.

Remember, additionally, that the United States with the active regime has not been very contributive or successful in these legal or wisdom directions, and excessively so, and I requested and wanted for Harvard Law School to add to the situation. I had, and still have, claims with the United States that would add to Harvard Law School working with myself concerning the S.J.D. doctoral law degree, but with the United States excessively being caused to not do its relevant work, I sought directly for Harvard Law School to add to and boost the situation. With both parties not doing the relevant work involved or contributing to the fully explained situation, a conundrum was caused, as was more than 30 years ago, but because of so much being known, understood, and fully explained about now after more than 30 years, the conundrum should not continue, and progress should be made for all involved, including myself, Harvard Law School, the United States, and the American and global society.

I recently have been including money from my claims for fees that Harvard Law School would have if doing the work involving me. This went on through the whole year of 2025. With the United States excessively not taking care of anything relevant involved, in October 2025, I filed an SF-95 form with the Department of Justice and the White House. When there was still nothing by the end of December 2025, I did more with the SF-95 form and again filed it with the Department of Justice and the White House. The present time is three months into the SF-95 form.

With the SF-95 form, I am also saying that I am open to and looking for settlement offers being made to me. If the United States does not communicate to me a settlement offer and causes a Federal Court law case to be necessary, the only cause of the law case would be the United States, so I would request all court costs and legal fees be paid by the United States. Based on the United States situation and what I have been hearing, I am also a little

questionable about the Department of Justice with the current regime, so also I am saying that since this is the United States and I have claims concerning the United States, I have to have full security and authority that I am supposed to have with the United States. I have been working on the legal issues involved for more than 30 years, so I have to have full power concerning this case and be able to do the law work involved and be known and understood as an officer of the court and have included "Your Honor" and "Honorable" when any formal reference is made to me. This situation if kept in a right, respectful, and lawful way could be a good learning and developmental experience for me.

By the way, you may not know it, as many others do not know it, but the Republicans are not communicating at all yet. That was out of the whole year of 2025, and substantial efforts for communication with the Republican National Committee (RNC) were made since before and through the summer of 2025. Attempts for business were made with the RNC, but there was totally cold nothing from or of the Republican Party. These people did not communicate and were not communicating at all. They were ok themselves and were already being paid and functioning on good levels but were not collaborating or communicating with anyone else. They likely had themselves so well off with the current United States regime that they did not bother with and ignored everyone else. What also turned into a likely problem for them was that they became so entangled with and dependent on the current regime that they were afraid to do anything else or anything more, and the current and continuing situation is very concerning.

In all these circumstances I described, Harvard Law School could add. Harvard Law School is a school, an advanced school, and has advanced teachers and instructors who could add to teaching and guidance for people with these active situations and could really use the guidance. There could be an adding into how such situations could or should be handled, what are correct ways of doing activities, tasks, and projects, and working with people involved, and why many of the areas involved are important and must be worked with successfully.
