

**Following Decree of 2025 U.S. Immigration Plan and Universal Laws,
Focusing on Trump, the Trump Administration, ICE, and States such as Minnesota**

Part 1

1. Trump, the Trump administration, Immigration and Customs Enforcement (ICE), and states such as Minnesota, are to review and assure handling the immigration issue in a right way and are to explain the logic at least at the length of a page or a screen.

2. The facts and details of the people of age and functional ability from outside of this country, U.S.A., have to be documented first and foremost by themselves so they know what they are doing and where they are supposed to stand, and beyond this, and with the use of current technology such as computer systems, ICE and the state, such as Minnesota have to have reported – documented that each of these people are on track for visiting, staying, or becoming a U.S. citizen. Any issues (of vetting) can be pointed out by these people, ICE, or the state, and these issues can continue being worked on and advanced to resolution.

7. The work on sorting all the involved IT information of the intent and activities has to be done by who is doing that type of work, such as ICE and the state, for these people to be involved with what they want and advancing at immigrating here or just visiting, and also the people of this country, U.S.A., such as with ICE or the state, doing the work on immigrations or visitations have to be doing the rewarding professional work they want to be doing. If there was any injustice or illegality that happened, the issue has to be addressed specifically and worked out among any parties involved, including as to whether any fair and just penalty is appropriate with the intention of illegality being reduced and eliminated from immigrating or visiting this country and keeping safe and sophisticated national borders.

Technology of the modern times is necessary to use to handle all the considerations of the involved information so that all the details are conveniently sortable, retrievable, and functional, and with the amount of funding the parties like ICE and each state has, there should be no problem with the funds available to use and having them be kept not excessive or deficient.

Part 2

9. If there is any intentional wrong, injustice, or damage to any party or the system of working with national borders, the wrongdoers could be penalized with small fines or bans that could be increased if anyone continues the infractions or problems, although the purpose of any of this penalizing is not just to penalize and is to add to keeping the national borders secure and the workings fair and honest to all.

10. Right people have to be in the right jobs concerning immigration. These jobs have to include being properly regarded, respected, and honored and have to have the pay, along with the work, work hours, and benefits, be right according to U.S. national standards for the particular status level of the job. People who have had the types of qualifications that go into these kinds of jobs but have not been worked with yet or have not had these jobs in a while, have the top priority of being put into these types of jobs. Working with these people has to be done enough to ensure the professional position is correct in all important ways and some catching-up may be appropriate as additional following up may be necessary so that these people are heard and worked with to points of mutual contentment. With Trump and the Trump administration having seven years of these areas requiring, and including the entire year of 2025, which was the eighth year, the laws and duties regarding these American jobs have to be implemented without longer being necessary and without Trump, the Trump administration, ICE, or the state, proceeding with these American jobs still not being done.
