

**Executive ORDER by Mallon for Freedom and Reward concerning the United States,
09-05-2026**

Many people have been expressing discontentment with the current administration at the White House but without doing anything about it or enough about it. When attempting to do something about the situation, many people find out that it is harder than it seems. There are many businesses and people with lots of money, but they are not all organized and unified, so there are many important endeavors that they cannot just accomplish by themselves, especially when the mentioned administration is taking, diverting, and hindering resources, including funds and media attention. Political parties alone are not an escape route, because the Republican Party has been being totally controlled—monopolized by the mentioned administration and the Democratic Party has not been functionally much different. The only way is the necessary way of siding with—allying with—who already has a substantial and worthy well-established existence separate, different, and alternatively-powered from that previous administration.

The only one in the United States and on Earth and in history who is a person with the mentioned attributes is myself, Joseph Mallon, and the administration in this potential-loaded way is my administration, political organization, and side. I have many years already of everything in these relevant directions, but also, I am a real person, and I have not been dealt with at all yet in more than 30 years. I should have been dealt with and rewarded and honored through all those 30 years but was excessively not, and that was an injustice to me and many people and on many levels. The effort and intent is to fully overcome that injustice, secure against it, and remain happy, safe, successful, and free through the active times and for a legacy.

There has been tremendous and steady successes achieved in these directions but has to be continued successes and higher levels. Funds are needed for these purposes. Eventually, there will be practically unlimited funds after there is the God's Miracle Cross currency well established globally, but the present times are before those points, and the location is in the United States of America, so American dollars are needed for funds. Some organizations are set up to raise funds, some organizations make money in ways other than raising funds, and some people have lots of money from some source relevant to their background. The key here is the realization that everything is not that previous administration, and these sources have to be used in these differing and worthy directions.

The political parties and political action committees are the parties set up to raise funds. These parties have to be raising funds with myself included. I have more than 30 years of rights and background for this fundraising work being done on my behalf. I am the one who has the worthiness and potential and connects beyond just myself and in the moments.

The parties such as political packs and the Republican Party have to be raising funds here so that people involved with these parties are free to function and make money, too. They would be making 2 or 3 percent of whatever funds they raised or whatever the going rate would be at the time. I have rights to use the Republican Party along with associated organizations such as PACS, because those parties are set up to function in these capacities in the United States. I have rights to function and benefit without reinventing the wheel or, in other words, without doing everything over myself when in other times of history and with different perspectives, resources, and potential. I was present and worthy of being rewarded and honored before most, if not all, those of that previous administration and continued with rights and merits through all those past years to the present and beyond 2028.

These years I mentioned factually involve the time of the career and life. Much significant and effectual is involved. People's lives and careers are affected in one way or another. Many specific efforts are made, so for some of these efforts and work done to be worthwhile and reasonable, there has to be security and authority where it belongs. I already have a Federal Court law case established that can help at serving these purposes. The previous administration has not been regarding anything and has not been enabling other parties, such as myself to be making relevant money or having opportunities in the times—years. This situation was so bad that after a very long time, I made an SF-95 form, which justified a Federal Court law case if not being answered in 6 months. Six months went by without the previous administration answering, so the Federal Court law case was made. So far, five months have gone by with the Federal Court law case active and that previous administration not answering, paying any money involved, or working out anything relevant, including pay or opportunities. This side—the side that includes myself—is the side that has all that, including with the valid law case. This already valid and substantial Federal Court law case has to be enough for a worthy active law case, for the work to be done on these U.S. national levels concerning the United States Presidency of up to and beyond 2028, and for there to be no unjustified, unproductive, or unmerited contestation, including by law.

Further, I am the one who made the mentioned law case, 26-cv-02712, after having an extensive amount of justification, so I already have rights to full security and authority with that law case. A part of that security and authority is for me to be being adequately paid as the present times are passing by, even before large money amounts are raised by associated parties, such as the Republican Party or PACs. I have to have a minimum pay of at least \$2,000 a week until more money is made possible to me. That minimum pay is necessary in the U.S.A. for there to be fairness and legality of there being beyond a minimum wage. Before anyone else can be paid in these directions, I have to be paid, so I am in the way of anyone else being paid in these directions, and although I had my worthy and meritorious professional and official material with that previous administration through the past more than seven years, that administration has not paid me yet to the points of the mentioned Federal Court law case, so the active Federal Court law case has to provide and should provide the security of being lawful beyond the minimum wage rate in the United States.

This Executive ORDER is that there immediately and continuing be, by law, beyond at least a minimum wage rate of pay paid to me for any continuing work I do here in these United States directions and that organizations, such as the Republican Party and PACS, perform their duties of fundraising and enable their members being free and rewarded for doing their work.
