

**Executive Order by Mallon Describing Legal Basis—Authority for United States to Pay
Funds Sought, 09/03/2026**

Today when I am typing up this document is September 3rd, 2024 and is still before I have been dealt with at all in any way relevant and requiring through the past years to now. Nothing has come through to me yet in regard of working out the situation, which is following active communication from me through the entire year of 2025, into 2026, and up to now in September 2026. To show I did communicate and could be communicated back to, I have the White House April 2nd, 2026 letter to me, which did not address the issues involved with my materials and did not work out anything with me. I communicated in a few ways, and one of those ways was by means of filings I have been making electronically at the White House. The letter comes from the electronic filing because I received the letter by email, and nothing is mentioned, worked with, or worked out concerning anything that connects to the other communication means, and in addition, the letter does not work out anything of the bounds of the electronic filings, but the letter was sent to me electronically by way of to my email address, which is included in the electronic filing. That letter was April 2nd, and now is more than five months later with nothing additional relevant to that letter or anything else.

Through the times before the letter, I had my SF-95 form active. My SF-95 form could have been responded to with the White House letter but was not and remained separate. That is when I had to make my law case, 26-cv-02712, in a Federal Court because of the United States not responding to my SF-95 form and working nothing out with me. Five more months further went by with nothing coming of the Federal Court law case and nothing being worked out with me.

As my law case is present in a Federal Court, the judge assigned to the case has to work on the case, declare its outcomes, and confirm when the case is concluded. I need something to come of the law case so that I have something more to do instead of not being regarded with my important materials, issues, and rights. With or without that, I have rights and authority but was caused to need something more than myself just having rights and authority, so that is why I made the SF-95 form and then the law case following. I had the rights and authority and filed my materials at the White House through all of 2025 up to the present in September 2026. My law case is for me to have something more than only

myself being present with rights and authority while being left not regarded and with nothing worked out concerning anything relevant involved.

I have the authority, which is also the legal basis, for my claims I communicated about through all of 2025. As of October 2025, I had that same authority, and legal basis but plus I had the added authority of the SF-95 form. After six months of the SF-95 form, I had my original authority—legal basis, six months of the SF-95 form, and then a Federal Court law case I made. Nothing came of the law case yet, and the case is not concluded, but I have my authority since before this law case, of the six months of the SF-95 form, and now five months of the Federal Court law case.

I still need something more, but that is why there is the Federal Court law case I made. I need something more because I have not been dealt with yet. Nothing was worked out with me. As much as I say and express in any way appropriate, I am still left with the same situation. I still have no where additional to communicate to and no where additional to go for any of the issues involved to be advanced. I have not yet been paid when I have to be and am supposed to be, and I should receive payments in the form of direct deposits or paychecks based on my described authority—legal basis, which entitles me to my sought funds.

After my explanation here, everything still requires, even though I have the described authority—legal basis, so that is why something more is still needed. Something has to come of the Federal Court law case I made. In the meantime, though, I still already have the described authority—legal basis for being entitled to the funds I am requesting to be paid to me by direct deposit or paycheck.

What funds am I requesting? I am requesting the United States government, the defendant of my law case and the party with vicarious liability for the administration at the White House where my filings were made through all of 2025, after seven years previously, and up to now in September 2026, to pay me a pay of a reasonable amount for a salary, such as \$2,000 weekly, for now until when more is worked out. What more money is there to work out with my described legal basis—authority? For example, there are the court costs for the Federal Law case that was caused by the United States with liability for the administration at the White House—Trump and the Trump Administration. Other money amounts are the

\$9 million requested in 2025 and then doubled to include 2026, so that is \$9 million and \$9 million or one lump-sum of \$18 million. In 2025 I also requested \$1 million be set to establish a God's Miracle Cross fund that includes God's Miracle Cross currency of crosses and faces where the faces are equal to cents and each cross equals one dollar, and then that was doubled for 2026, so that would be \$1 million and \$1 million, which is \$2 million.

I also previously requested for there to be 5,000 paid personnel assigned to work under my authority because of the national emergency situation.

Therefore, I hereby issue this executive order for the United States to pay by direct deposit or paychecks the money requested under my authority—legal basis to be paid, and those amounts are \$2,000 weekly paycheck or direct deposit for a pay of something until more is worked out, the court costs for the Federal law case, 26-cv-02712; the \$18 million requested for 2025 and 2026, the \$2 million for starting the God's Miracle Cross currency fund, and any pay due to any of my previously requested 5,000 people who are paid personnel.
