

## **E-Letter to Harvard Law School, 02-22-2026**

I asked about being worked with at Harvard Law School for the Doctor of Juridical Science (S.J.D.) degree being issued to me. People at Harvard Law School did not work anything out yet for any activity or for a six-week session that I suggested as a possibility. “A six-week session, such as October 15th to November 26th, 2025, January 5th to February 16th, 2026; or March 9th to April 20th, 2026, would be something that could be worked out” (Letter from 09-21-2025). The last of these session times is coming up, “March 9th to April 20th, 2026,” and there is nothing worked out for it yet.

With Harvard Law School not working anything out with me for the six-week session, no one of Harvard Law School can expect me to be there on campus during the session of March 9th to April 20th, 2026. What other, if any, arrangements does Harvard Law School have that are possible? Is there another six-week session that there can be? Did Harvard Law School do anything yet or make any considerations of the “unique project I mentioned about in my recent letters?” Right now, I am mainly questioning about working out the six-week session. Nowadays, such a six-week session can be done remotely. If Harvard Law School wants to work out the six-week session for being remote—online, that can absolutely be done. What does Harvard Law School suggest, if anything, for the “unique project I mentioned about in my recent letters?”

If Harvard Law School has more to confirm or work out with the United States yet, I understand that and recommend that because the present situation is still with the United States having left open and active, my SF-95 form, along with my 7 involved claims. The time is now more than 4 months. If 6 months is gone through, and the United States does not present anything to me, a federal law case would be caused. Do people presently at Harvard Law School understand that it takes something to cause a federal law case?

Additionally, I presented to Harvard Law School my materials, questioning about the unique project being worked on at Harvard Law School and having a six-week session for that purpose, about a month before I made my SF-95 form. My original 7 claims were with the United States through the entire year of 2025. My SF-95 form was signed for on October 15<sup>th</sup>, 2025. As said, four months passed by so far with the United States having my SF-95 form. Everything on my part is not and does not have to be considered as limited to the SF-

95 form, but I made the SF-95 form as an effort to help the situation at being worked out with the United States involving me.

Also, I will summarize the unique project I mentioned. I am the discoverer of God's Miracle Cross, which was an extraordinary object I discovered in 1981 and worked with through the next years. I was in law school 10 years later, and with the situation not being right or fair with law school, I wanted Harvard Law School to work on the situation, and I eventually made law cases in U.S. Courts concerning the whole situation, and with Harvard Law School included. Nothing relevant was worked out with me, so mainly, everything remained requiring. Through the next years, I worked and worked in various ways. I acquired a Master of Business Administration (MBA) degree and then worked through a doctoral program. I completed the doctoral program and did very well and with an A grade level grade point average (GPA) and a very good dissertation. The university, the University of Phoenix, did not complete its part of the doctoral program and left me unrewarded and still just doing more work. I did more work and worked with, but then beyond, the University of Phoenix. I completed my post-doctoral dissertation in the summer of 2019, and in these years of 2017 to 2019, I was communicating to the White House, and I informed the White House of what was going on and including with my post-doctoral dissertation. Nothing was worked out with me, so I continued working and working on my advanced levels and continued doing very well, but without the reward and honor due. I then decided to bridge the past 30 years together and make my dissertation into a doctoral law dissertation. I did that and completed my doctoral law dissertation in the end of 2024.

I was not dealt with yet. Out of all that in 30 years, formal doctoral levels academically, previous law cases, working diligently and steadily at quality companies in the society, and having active communication with the White House, being the discoverer of an extraordinary object, having an innate identity and societal status, and now having three high quality dissertations, and being actively licensed in insurance and with securities licenses of 7, 6, 63, 26, and 65 and directly knowing the current state of licensing in the society, so now I wanted it all dealt with. I want the rewards and honors due me. I want to be compensated at least as best as possible. I want my licensing secured, including up to a United States level lawyer's license. I want my doctoral status academically, including up to the S.J.D. degree from Harvard Law School. Harvard Law School can issue me a J.D. degree, an LL.M. degree, and an S.J.D. degree or just issue me the S.J.D. degree, whatever is best for Harvard Law School.

Now, I have all that, and more like that, in my background. I communicated since last year to Harvard Law School about this unique project. I have a doctoral law dissertation I completed in the end of 2024 and that Harvard Law School has not seen or worked with yet. There has been very much significant and relevant in the society, especially with the United States, although predominantly no one knows the background information I mentioned about, at least right now and until, perhaps, after the due rewards and honors are bestowed.
