Motion to Take Care of Professional Aspects of this SF-95 Federal Court Filing

One of the first areas to work out concerning the commencement of this case is the professional area. Progressive results can be produced but enough has to be done immediately. Please have set up a salary of \$2000 weekly and a backpay of \$1,000,000, by way of direct deposit or check; understand, recognize, implement, and honor the status aspects of referring to me in an honorable way, such as with “Honorable” or “Your Honor,” and have included functioning with a status level of doctor, executive, and advanced level lawyer, judge, and U.S. official.
