I had three email addresses for Harvard Law School. The following response is what I received from the gpquery@law.harvard.edu email address. I will not currently send another message there. I am still questioning concerning the other two email addresses I also sent relevant communication to recently: deansoffice@law.harvard.edu and jdadmiss@law.harvard.edu .

I request that my letters be looked over and that the unique project I described be seriously considered for Harvard Law School taking it on to contribute to the situation and advancing it because of the extraordinary circumstances involved. If you here at Harvard Law School intend to do anything constructive in this direction, I request word back so that I know where the situation stands.
