I am an American, a U.S. Citizen, and a very important and historic person who is effectual to the United States and Americans. I have significant claims concerning the United States. I requested my claims be secured and advanced, and I requested communication back informing me of such compliance, cooperation, respect, and honor. I included the student loans information also and including with the applicability of precedent authority. You have included nothing so far and have worked nothing out.

You have U.S. Presidential campaigning going on, and because you have all my areas left out, not honored, and left excessively neglected and still requiring, I call into question any validity you have, or seemingly have, concerning a U.S. Presidency and what is going on concerning voting and elections. I accuse you, and everyone involved here accordingly, with sabotaging the U.S. empowerment systems and destroying the property of the United States, against the United States and American people. This stance likewise goes for the Republican and Democrat parties and all Democrats and Republicans that you are not representing and are contrasting, impeding, damaging, and depriving instead.

I have heard that I have to do more, and have to do everything for myself, so I am authoritatively communicating more and express everything for myself and by myself, as I did, and now and ongoing, you have to be responsible for it and held accountable. Emailed to the United States - White House on 10/07/2024 - Second

I explained that I have significant claims concerning the United States and that these claims have to be secured. My letter mailed to the White House in hard copy form was dated June 22, 2024. Following, this letter was emailed in electronic form. I expressed about my relevant career spanning the past more than 30 years. I included the student loan information. I abundantly expressed why I should not have to go any longer at all without a sufficiency of these areas being worked out and why I should expect an immediate favorable response.

If the lack of a sufficiency of my areas being included or advanced was caused in any way at all by political campaigning, including U.S. Presidential, I hereby immediately declare that as needless delay. I should not have to wait until after the U.S. Presidential election before I will be dealt with or regarded at all, and if even then. I declare that whichever way the U.S. Presidential election goes, or any other political campaigning, I immediately have rights and authority concerning all involved with my claims concerning the United States. No matter who gets in there as an elected, or seemingly elected, U.S. President, I declare my rights and authority beyond that person and that I have to be honorably treated and dealt with concerning my claims involving the United States. I question that person's authority and declare my authority. My claims were there first. My claims should be, and should have been, dealt with first.

Remember that I communicated validly and worthily to the United States and not merely to a political person or political party. After any seemingly political outcome in November 2024, I declare my United States rights and authority and that my claims concerning the United States have to be secure, advanced, and successful.

Are you here of the United States at the White House going to communicate or not? Your automated response says that you are working diligently to provide an appropriate response. You are doing that, aren't you? How much time is that appropriate response going to take? I have already gone through three months before there was that appropriate response. Do you realize that you have not responded yet? How much effect do you think such a lack of a response would have on an important national issue? You have not yet replied as you said you would reply.

I do not have time to just go endlessly longer and longer. This aspect is what I originally said about in my June 22, 2024 letter I sent in hard copy and electronic forms to the White House. I said about the issue of having much relevant but then only seeing time going by without anything present dealing with the important aspects involved. I said I do not want to merely see nothing there when I look. I said that in my times and years of my career and life, I have to see more than nothing there. I cannot just be left with nothing in my career and life.

If you do not communicate back to me reasonably as the ongoing time passes by, I will continue communicating as I should on my levels and will consider everything on your part as I express and you and anyone at the White House or of the United States being under my authority and required to comply, cooperate, facilitate, enhance, respect, and honor all aspects involved on my part, myself and my rank, status, career, and history included. I have substantial claims concerning the United States and I need and requested for my claims to be secured and advanced.

You must have forgotten to pay me my paycheck for this pay period. I requested my claims concerning the United States be secured, and a part of my claims is my paycheck being paid to me in a timely manner on payday. My professional position concerning the United States has been U.S. Executive Director. Please look into this pay matter because I have rights to my pay. I already worked through the active pay period, and my pay is already due. I have bills to pay and things to do with my money. As I previously said in my communication to here, the White House, I cannot just go longer and longer without being paid. My creditors do not like that and do not want to hear about excuses, even if they are justified. Now, please pay me my money as I requested because you owe me. The United States owes me. Stop being in the way of the United States paying me my money and taking care of the responsibilities of the United States.

Please reply as soon as possible because I cannot and should not wait any longer. I have waited long enough. Also, I justifiably will not tolerate waiting any longer. Remember that my letter sent to the United States at the White House was sent in hard copy and electronic form and was dated June 22, 2024. I have now been through June, July, August, and September 2024 without my pay from the United States and that the United States is supposed to pay me. In fact, my pay is due me from at least the Trump administration times, after there was an extensive amount of my material there in the Trump administration following more than a quarter-century and when America and Americans were supposed to be even more so dealt with and with an America-first emphasis to make America great again. I am still here requiring to be dealt with and have not been properly dealt with yet or paid. I DEMAND to be immediately and continuing honorably dealt with and paid, and I ORDER the work to be done.

October 15, 2024 - Part 1

I was in law school in the early 1990s. I went into law school after significant experience I had through the previous 10 years and doing well through college and graduating from there summa cum laude. I did and had more than the law school knew and really had to have and should have had the meritorious aspects involved dealt with, rewarded, and honored. I knew what was going on when the Iraq War broke out and continued in those times. I articulated much of the knowledge and made reports with law dominance.

After having much material accumulated but still not being worked with concerning that material, I made cases in the U.S. Courts. I went through the next more than a year working on those law cases and doing very well myself but still not being dealt with, rewarded, or honored as I should have been. The law went not dealt with, and I primarily had to do everything myself as best as I could and only using natural law, which I did and did very well but still was not dealt with, rewarded, or honored. The United States was one of the primary parties involved.

I was the discoverer of God's Miracle Cross, which I discovered when I was 20 years old and worked with through the next 10 years to when I had the law cases active. The United States was communicated to since 1983. I should not have had to make law cases in the 1990s, but I had to and was too justified. These law cases ended up not being dealt with, rewarded, or honored as they needed and deserved.

October 15, 2024 - Part 2

All was abundantly worked well with through the following years, and much was proven and evidenced on my part, including concerning the United States, but still, these areas had to be dealt with, rewarded, or honored. This situation involving the United States went on up to and through the Trump administration times when I had material present at the White House and requiring to be dealt with, rewarded, or honored through all that time. The student loans were one of the national issues active through that time. I included this aspect in my reports. This situation ended up continuing into Biden's times without Trump having done anywhere near enough. My approximately \$250 thousand student loans were fully discharged, but the rest involved directly and indirectly has still not been dealt with yet. I have been actively communicating through this White House electronic Internet communication line recently since the summer of 2024.

Since I was previously in law school and then made law cases in the U.S. Courts from the District Court to the U.S. Supreme Court, I request these aspects be included in my claims concerning the United States and that, thus, I be rewarded my law degrees from a qualified American Law School (which could be Harvard Law School issuing to me my J.D. Degree, LL.M. degree, and S.J.D. degree) and lawyer's license (state Pennsylvania or national level to be made), (Court Case Numbers: 92-3242, 92-1736, 93-5183, and 93-0001, more than 30 years of active, important, and national law and issues;

Please turn over my lawyer's license and law degrees to me as soon as possible. Also, I could use some of my money, so I additionally request a payment of some money owed to me.

Emailed to the United States - White House on 10/16/2024

If you here of the United States work on my claims concerning the United States, you see that one of my claims is involving United States law cases where I am supposed to be honored. If enough is worked out in honor to me, I can be provided with my lawyer's license and law degrees, up to an S.J.D. degree. I want to know if some U.S. Attorneys can start working with me right now and continuing to establish and advance law cases in some U.S. courts.

You can see that there are many laws involved with my materials. There is much applicable for case law, codes types of laws, and legislative laws. Most, if not all, is not worked through yet but is requiring, as it has been, for more than a quarter-century. All this law area is very important, but some of the top priority law being worked on and worked out first would enable other law to be worked out following. That is why I request some U.S. attorneys to immediately commence at working with me, my materials, and claims concerning the United States and to establish some law cases in U.S. courts.

I do not want time to go by without enough in right and lawful directions. There are opportunity costs involved with the time going by without a sufficiency in right ways. There have already been too many such opportunity costs, and I do not want any more, and I do want more to do about everything involved. Of course, that is a part of why I have claims concerning the United States.

I request that U.S attorneys contribute to this worthy cause area of my claims concerning the United States and communicate to me for the purpose of advancing the law involved, along with everything else, that is very important to the United States.

Emailed to the United States - White House on 10/18/2024

I communicate here to the United States by way of the White House. This communication line is one of the few, if any, you people of the White House have open. You really have an excessive lack of real communication lines, and I am, as I have been, requesting improvement of the communication.

I explained myself and why I am justified to communicate to the United States by way of the White House. Thus, I did what I was supposed to do, and I am validly complaining that I do not see a sufficiency on the part of the people associated with the United States. I cannot just be not regarded or not communicated back to because that is not what is supposed to be done, is not accommodating me, and is not taking care of any issue involved.

I requested previously that U.S. attorneys communicate back to me to advance law and issues involved. I did not yet receive any communication back from a U.S. attorney. I am here by myself, and I have claims involving the United States. My side is the prosecution. When there is a law case where the United States is the prosecution and the other party is alone, in many instances a public defender is assigned. In the present instance, I am requesting the United States assign U.S. attorneys as public prosecutors so that I can be worked with concerning the laws of the claims involved.

How can you have a valid U.S. Presidential election for 2024 when the American people -- the voters -- do not know any of the vital information concerning most national issues, including merits for official positions? Such an election is not valid. The media has not covered anything relevant. The uninformed voters cannot express valid consent in the form of a vote. People responsible for deliberately causing such a situation are involved with illegalities and also are damaging and destroying United States property of empowerment systems. I request U.S. Attorneys communicate to me, or be assigned to communicate to me, to secure the law involved.

I have not yet been dealt with, honored, or paid, and I have to be dealt with, honored, and paid. I communicated in these active times to the United States by way of the White House since my letter dated June 22, 2024, and I sent that letter in hard copy and electronic form. I said about having claims concerning the United States. I request that my claims be immediately and continuing regarded and respected and that I be dealt with, honored, and paid.

My official professional position with the United States government is and has to be secured and respected as chief executive director, which is what is has been through the past years, not just right now but through years already. I do not care what anyone else thinks or says, and anyone else cannot have any effect on me, regardless of what anyone else thinks or emphasizes. I do not mean that in a bad way, but I mean that in a way of upholding my authority, rights, status, and independence, also knowledge, experience, and potential.

I was 20 years old when I discovered God's Miracle Cross, and I then worked with it through the next year before truly and fully knowing it was an authentic miracle. I continued working with it and eventually communicated to the United States by way of the White House. After around 10 years, I went into law school and the first Iraq War happened. About a year following, I made law cases in U.S. courts. My law cases were not just fully honored or worked through, so now since these areas, laws included, are still requiring more than 30 years later, my law cases, and all involved, as best as possible, have to be fully honored and worked through.

I request my pay. I request my law degrees to the level of a doctoral law degree, such as S.J.D. doctoral law degree. I request for U.S. attorneys to be assigned to do their jobs of dealing with me respectfully and honorably. I request my claims concerning the United States be secured and advanced, including by law.

Are U.S. Attorneys assigned yet to assist me with much needed law cases for some U.S. courts? No one communicated to me yet about this matter. Can you have a U.S. attorney or staff assigned to communicate to me about securing prosecution in U.S. courts and/or advancing my claims concerning the United States?

For communication, we can talk on the phone. We can use online systems, such as Zoom. We can use emails, which includes my email, that is already noted. I would rather not wait for the postal service, but you can use the postal service; you have my PO Box number. For us to conference in person or directly, you would have to arrange that with me and accommodate me with the arrangements.

I did previously say about wanting my law credentials up the level of an S.J.D. degree, but I do not expect you here to have that all worked out immediately, and if you at least have that law case claim advanced, that would be acceptable. For your information, the law school I came from when I was no longer appropriately worked with was not Harvard Law School, which is still the primary law school of my claims, but was Widener Law School in Pennsylvania. We could meet there, if you here would like to make accommodating arrangements with me and the law school, where I have not been since back then in the early 1990s.

I could also use some payment of money due me from either my claims concerning the United States or from a bonus or my actual official professional position, U.S. Chief Executive Director. I need the money, for many reasons, but also the situation would advance in a positive, mutually beneficial, and long overdue way like that. Back around 20 years ago, I used to appropriately request a \$10,000 bonus. Now, 20 years later, what bonus would you offer to me at or beyond \$10,000? Also, even if you provide me with a bonus, I still keep my independence and uphold all I have previously emphasized, especially officially.

Actual posting made with spacing considerations –

For a long time, the media has been loaded with descriptions of U.S. Presidential campaigning. What do I have to do with any of that? My status relevant is significant but excessively requiring.

Trump owes me VIP status. I expect that status to be ongoing and involving anything and everything. I not only insist on that caliber of a regard but, as I have said before, I have to have my security and authority concerning it. I must always have my independence, wealth, advanced professional level, and honor with or without Trump. Trump owing me this VIP status comes from Trump taking more than seven years to deal with or regard anything relevant involved.

I am owed a ton of money. You can see by my claims concerning the United States that I have an extensive amount of money and wealth involving me. You can also see that I have a tremendous amount of wealth involving me by my communication that I sent to the United States by way of the White House since the summer of 2024. I want and need the wealth, including money, I am supposed to have and to not be just explaining about it.

There are excessive gaps active. I have been complaining about the deficiencies. Remember that I was not dealt with yet and had to be dealt with. People involved took an unreasonable amount of time to deal with me or issues involved. I made law cases about this unjust situation. I have a doctoral dissertation and a post-doctoral dissertation that address these areas. These aspects were a part of the student loans situation and justification for having the student loans discharged. This area of excessive deficiencies involving status and wealth was very much a part of my communication recently made to the United States by way of the White House since June 22, 2024.

I request the situation be updated and straightened out. Please relevantly communicate back to me with rightful intent for improvement and advancing my claims concerning the United States.

Emailed to the United States - White House on 10/29/2024

Where is my bonus? I received nothing yet. You have to send a check to me at my post office box. Eventually, you will be able to make direct deposits. The best payment method you presently have is to just mail a bonus check to me.

How much money is my bonus? A right bonus amount paid to me by the United States should be \$50,000. That does not have to be my only bonus but would be a good starting bonus from the United States paid to me. I specifically say the United States because I want the bonus accounted for and to actually be paid to me without any playing around. I have not been paid yet and have to be paid.

Most of the rest is that my claims concerning the United States have to be secured. There has to be enough people here of the United States working on these areas. A report has to be made to me. Communication with me has to be adequate. I use electronic, hard copy, and direct communication.

I have things to do. My time is important. I have to have my money paid to me so that I can buy things. I have to have my U.S. claims advancing. I am currently advancing my post-doctoral dissertation and am making it a law dissertation for a law school, such as Harvard Law School, to work with and issue me my S.J.D. degree. Right now, the United States has to influence Harvard Law School to do its work so that my doctoral law degree is on track at being issued to me.

There is more. When I make an emphasis concerning external parties, I have to be regarded accordingly and to levels of persuasive and binding authority. The Russian-Ukraine and Middle-Eastern situations have to be adequately settled and progressing. Activity involving areas of China, Japan, and Korea-North and South, have to be reasonable. Border issues have to be straightened out correctly and lawfully. The U.S. economy has to be secured at improving. Advancements of humanity lifestyle, healthcare, and space exploration have to be active.

I request and ORDER the work done and communication made.

I do not support the militaristic activity concerning Ukraine and Russia. I support the immediate and continuing use of diplomacy, humanitarianism, recovery, and rebuilding. Right ways have to be gone and not wrong ways. Promoting militaristic activity in the Russian-Ukraine area is a wrong way to go. If North Korea puts any military people into the issue area, they must be told to not do that and to leave. South Korea should not be let to or advised to go into the issue area, either, and must be told not to go in, just to be against North Korea. In truth, the United States or the World does not support or want the needless military activity.

People of or in the issue area can and should be on defensive, but there cannot legally be any offensive that is with bad intent, causes any damage, or hurts or kills anyone. NATO cannot legally be involved with or cause any hostile activity, either. Is everything set up sufficiently with the claims I have concerning the United States?
