Motion to Authorize Mediation for this SF-95 Federal Court Filing

The present situation of when this current law case was filed in the United States District Court for the Eastern District of Pennsylvania is after more than six months since I, the plaintiff, Joseph Mallon, sent a Standard Form 95 (SF-95 form) to the United States at the Department of Justice and the White House in Washington, D.C.
