

I sent a letter in hard copy form to the White House recently. I did not yet receive any word back in response to the letter or in terms of working out the issues involving the letter. Now, with the situation going on at the White House with Biden withdrawing from continuance, I do not know if I am going to receive any response or be dealt with as I should be concerning the issues involved. However, the United States is involved and remains involved with these areas that have years of substance and importance. Trump assuredly does not have these matters dealt with. The situation appears to presently be that nothing was done with the letter and that nothing is presently being worked on, although the letter was very important, was there after years of relevancy, and was truly valid, active, and requiring.

I included here a copy of the letter. This letter is still requiring and the situation the letter describes needs to be straightened out and worked out in the active times and concerning the continuing times. I could say a lot more here, too, but I have to be respected and honored adequately with what I say and cannot just be saying things to no avail. I sent a letter to the United States and validly expressed rights and interests to be dealt with realistically in the immediate and continuing times. The responsible people of the United States have not replied to me yet and have not worked out anything adequately with me yet. They have been well informed, and the United States is liable. I am not trying to say bad or strick things, but I am saying that there are these expressed facts involved, I sent an important letter in the present times, and I expect to be adequately dealt with honorably with my views mutually included.

This letter was a nonpartisan letter. The letter was not sent to the Republican Party or Democratic Party, but was sent to the United States. The letter was sent in hard-copy form to the White House. The letter was dated June 22, 2024. I said about having claims with the United States. I have claims with the United States, and they have to be worked out in the immediately continuing times for the present and future times. I have to be pleased with what I see because I am supposed to be and do have to be treated right on the part of the United States and in respect and honor to my more than 30 years of material and my professional and official career concerning the United States.

The included June 22nd, 2024 letter is what I recently sent to the United States, and I presently still am looking for the United States to work out the claims the letter says about. The United States will need to have my authority secured with my rank and honor in order to work out the claims appropriately, and that may be the only way there will be any true progress. Ongoing, if I receive relevant word back, I will work with it, and if I do not receive relevant word back because of what is going on currently at the White House, everything will remain requiring without being settled or worked out.

June 22 letter –

United States,

I request that the United States work out the issues involving me concerning the United States. These issues, and who I am, should be adequately known about by responsible people associated with the United States (<https://www.godsmiraclecross.com/realm>). My material has been in the White House on numerous occasions since the early 1980s. I am the discoverer of God's Miracle Cross, which in its original form was an authentic miracle and is referred to as God's Miracle Cross. The design of the miracle cross was patented and copyrighted and, of course, significantly communicated about through the past quarter-century. I have involvement and rights with the United States, and I request adequate recognition and benefits from the United States in the immediately continuing times and without going longer or explaining more.

My career and professional position has to be secure and with pay, status, and benefits included. I have to have what I should have as the years go by and cannot be left with nothing instead. I made law cases in the U.S. courts back in the early 1990s, but those law cases and their issues and merits were not worked through, so now I request the work be done since then to the present and realistically and honorably (Dist. Ct. Case Number: 92-3242; Apls. Ct., 3rd Cir. Number: 92-1736; S.Ct. Number: 93-5183; G.Ct. Number: 93-0001). Because my material, and all involved, goes from more than a quarter-century ago to the current times, I expect everything to be put in current terms and forms and be actively and constructively worked on, including to my mutual satisfaction.

This is a claim. I have claims concerning the United States. I need these claims worked through. I need the benefits, pay, status, rewards, and honors from my claims and cannot just keep going longer and longer through my career and life without what is due me.

Claims I have concerning the United States are (1) God's Miracle Cross being dealt with on United States levels, (2) original law cases with the United States being dealt with since 1991, (3) United States professional and official position worked out and adequately and up to date, with pay and benefits included since before, and not limited to, the Trump administration times and including continuing through the Biden administration times and on until when sufficiently settled; (4) past money that the United States has indebted to me has to be adequately paid or being paid up to date; (5) the University of Phoenix claim of \$500 million has to be paid to me,

and the issuance—turning over of my doctorate to me, and including adding on my post-doctorate, is necessary; (6) I have a \$109,441.71 hospital claim added on because of causing a healthcare issue that required a more than two-week hospital stay, and with no active healthcare insurance or benefits that should have and otherwise would have been there had these matters been adequately dealt with or worked out in or through the times on the part of the United States, and because I did not have active healthcare insurance, the hospital gave me an 80% discount which makes the hospital claim added on for the United States be \$21,888.34, and (7) my approximately \$250,000 student loans have to continue being discharged (Sweet v. DeVos / Cardona, No. 19-cv-3674, N.D. Cal.) and any of my student loans left out of the discharge have to be included and discharged in a ***Student Loans Relinquishment Honor*** that the United States bestows to me.

Please respond cooperatively and respectfully to this letter and as efficiently and honorably as possible would be appreciated.
