

Executive Order by Mallon concerning Woman who has the Wife Status, 09-03-2026

When I made my law cases a little more than 30 years ago, one of the parties involved was a female, a woman who was and was supposed to be my wife. I had her involved with my law case, and then I specifically named her in a law case. She is still the same woman, and she has to deal with me because she is my wife. We were supposed to get together and be and stay together. We were caused to be apart though, and that was excessive, so that is why I made a law case involving her, and now, 30 years later, I am issuing this executive order concerning her specifically.

The woman I am referring to was married to me in 1981 with my God's Miracle Cross. My God's Miracle Cross involving this woman was the same as a marriage. The situation was abused by me not being dealt with adequately because she was too far away for that. That mistreatment of me not being dealt with adequately concerning and by this woman was not the way the situation was supposed to be and was abuse of the situation of there being a long distance involved. The long distance and foreign country situation was not impossible to handle but was not possible to handle like that, with me not being properly dealt with. The distance was way too far for me to be not treated right

and for what was involved to be not worked out. She was my wife, and I had rights involving her. I would not have bothered with her if she was not my wife. I only wanted my wife. I did not care about her profession, and I cared about my wife.

After about 10 years, and plenty there in the years important, relevant, and serious, I made the law case I previously mentioned with my wife as a named party. This law case was made so that the situation could be added to and advanced for us to get together and be together. Not enough was done with the law case to help the situation, so I had to just keep working and working as I had been, but with a very difficult and unreasonable situation that included thousands of miles of distance and a foreign country. I had to keep up with and take care of all the normal basics as the time passed by, and I still always wanted and needed my wife and kept doing as best as I could involving her.

Because she was my wife, I always saved her place, and she always interfered with other women. She even interfered with any woman who may have otherwise been my mistress. Still though, she was not around doing her part, and that just left her place empty and her purposes unserved. She was my wife though, so I am sure I affected her in many ways. The law case I made was not just worked on to take care of the situation, so the situation could not be trusted ongoing through the next years, and I was very suspicious, concerned, and unsettled through those years. Why did she not herself do some things dealing with me? That would have greatly improved the situation. If she did a little that she could have and should have done, that would have made a world of difference when I did all I could do in the circumstances and could not do anything more.

In these continuing years, I did once make contact with this woman's parents, and her parents knew of the law cases I made, so that meant that this woman knew of the law cases I made, and it was not like she did not know anything because they knew, so she knew. She really should have herself done something more dealing with me, but she did not and was excessively and seriously not there. She was supposed to be around and was not supposed to be thousands of miles away and in a foreign country.

On the latest occasion before the present times, which are years, I was sending consistent communication to where this woman was known to have resided, and then after a long time of that consistent communication, this woman ran off and went somewhere else. My communication through the postal service would then come back to me as returned to sender and with no forwarding address. When I searched further, no one knew where this woman was or went.

I would also communicate through the social sites. The social sites did not work correctly. This woman did not communicate through the social sites. She often had material there on the social sites but never communicated. The situation appeared to be as though she was cut off from or distracted from communicating. She never answered any of the communication I posted in the social sites, and that was out of a lot of postings and many that were very meant, important, and in her best interests.

This woman was still my wife. She seriously was not dealing with me though, and an extreme amount of time of years was going by, literally seasons and years. The time was way too long and was no where close to being reasonable.

In all those years, when this woman was my wife and had a marriage with me, including with much substance such as thousands of dreams and many materials, she would not, did not, or possibly could not return my communication, including caring communication. In all those years, we never got a divorce. We still were not together, but that was nothing but suspicious, and because of that impropriety, nothing could ever be settled for as being legitimate and as all there was to it.

I stopped sending communication to this woman after she last ran off and did not tell me where she was, no contact information. She would not and did not send an email to me,

call me on the phone, or mail me a letter. I saw her on some website and Internet areas, and while I often posted communication for her, she never responded.

Time of this latest era so far is seven years. Much happened through the seven years. I still did as good as I could, although this woman was also supposed to be more around than she was through those years. While she was still my wife, we were still not together, we still did not get a divorce, and she still did not have her marriage or me dealt with. I considered that since she is not dealing with me, doing her part, or making good faith effort adequately, she does not have rights like that and is losing all her rights involving me.

This woman has a long way to go dealing with me. She has a lot to do to deal with me. She has to deal with me. That is her only way to have any rights involving me. She has to deal with me. I am not even sure how much she can do. I am not sure if she can do anything or if she can even deal with me at all anymore. I am not sure if she can even still be my wife and function as my wife. She used to be able to, but after more years for everyone, including her and myself, I am not sure if she is still able to as in the past. She owes me a lot and would have to pay me as she owes me as my wife, and that would amount to as best as that can be, if it amounts to anything at all. I would give her a chance though, and I would always be good for her. The rest I do not know and will have to see. All will be accordingly and as is good and right on my part.

The executive order from me is that this woman has to deal with me and has to be and know she is my wife and make up to me for the past more than 30 years that she was my wife and had a valid and active marriage with me. I order that no one go near my wife in any close or personal way, or there will be according justice because she is my wife and always was my wife and has to deal with me exclusively. Her wedding ring was God's Miracle Cross, and her marriage was consummated and blessed with God's Miracle Cross.
